October is Domestic Violence Awareness Month

Domestic Violence Awareness Month first evolved from the "Day of Unity" in October 1981by the National Coalition Against Domestic Violence. This day was intended to create a connection for all advocates nationwide working toward the same goal; ending violence against women and their children. This day of Unity soon became an entire week dedicated to a range of activities at the local, state, and national level.

Although these activities varied according to the program sponsors, they all shared common themes: Mourning those who have died because of domestic violence, celebrating those who have survived, and connecting those who work to end violence.

In October 1987, the first Domestic Violence Awareness Month was observed. That same year marks the initiation of the first national domestic violence toll-free hotline. In 1989 the U.S. Congress passed Public Law 101-112 designating October of that year as National Domestic Violence Awareness Month.

Thanks to great support from our community, we were able to participate in several fundraisers this month. Manny's Down Town Pizza, Plymouth House of Pizza, and Ashland Village Pizza and Grill teamed up and donated a portion of their proceeds to us. We also welcomed twelve additional restaurants who participated in our Dine Out to End Violence on Oct. 19th & 20th. (details on page 3)

We held our Clothesline Project on Plymouth's Town Common Oct. 6th. The project is part of a national campaign, a visual display that uses tshirts to bear witness to domestic and sexual violence. Each shirt is decorated to represent a particular person's experience and is made by a survivor or someone who cares about them. Following our Clothesline Project we held a Candle Light Vigil to honor New Hampshire residents who have lost their lives due to domestic

violence this year. Fifty percent of all homicides in New Hampshire in the year of 2010 were related to domestic violence. Advocates, law enforcement, community members; adults and children attended to show their support in breaking the silence.

A Walk Against Violence will be help on Oct.29th at 9:00 am starting at Plymouth State University.

In honor of Domestic Violence Awareness Month, we conducted several presentations within the community to better educate people on the effects of DV and what one can do to help.

Since 1981 Voices Against Violence has been reaching out to and supporting victims and survivors of domestic violence, sexual violence, and stalking. Our advocates provide understanding, information, and support to victims, survivors, and non-offending family and friends. Our services include a 24-hour Crisis Line, Court Advocacy, Police and Hospital Accompaniment, Systems Advocacy, Emergency Shelter, Support Groups, and Education and Outreach. Domestic and sexual violence can take many forms including physical abuse, mental abuse, sexual assault, verbal threatening, and name calling. It can affect anyone at any time: friends, coworkers, relatives, children, teens, men, and women. By acknowledging the existence of domestic and sexual violence and stalking in our communities, we can raise awareness of the problem and enable both victims and witnesses to take action and break the cycle of violence.
